**RESOLUTION DATED 24-06-2013**

1. Exercising powers conferred under section 4 (1) and (2) of the CG NIJI VYAVASYIK SHIKSHAN SANSTHA (PRAVESH KA VINIYAMAN EVAM SHULK KA NIRDHARAN ) ACT, 2008 (here in after referred to as "Act") The State Government has constituted Admission and Fee Regulatory Committee (hence forth "AFRC") for the supervision and guidance of the admission process and for the fixation/revision of fee to be charged from candidate seeking admission in a private professional educational institution.
2. Kruti institute of teacher education, Raipur is commencing B.Ed course from session 2013-14 therefore for the first time we are taking the matter of fees fixation of this Institute and for rest of the Institutions running B.Ed course their fees structure earlier fixed is to be revised therefore their matter is being taken up for revision of their fees structure for B.Ed course.
3. Rahod Education Society, Rahod and Konark College of Education, Janjgir although are running M.Ed. Course since 2010-11 yet earlier their matter for fixation of fees structure for 2010-11, 2011-12 and 2012-13 could not come before AFRC for fixation of their fees structure for above period therefore for above period

the matter is being taken up along with revision of their fees structure for M.Ed course for 2013-14, 2014-15 and 2015-16. Rest of the Institutions whose fees structure of M.Ed. Course has already fixed for 2010-11, 2011-12 and 2012-13 their matter for revision of their fees structure is also being taken up.

4. As desired by AFRC "College deposited processing fee and excepting a few, also furnished information. On visiting institutions, on the basis of impression, some of them have been found falling within group Very Good, some of them have been found falling within group Good, and rest except Vishva Bharti Institute, Konta, Dist. Dantewara have been found within group Average. So far as Vishva Bharti Institute Konta is concerned, Member (Medical education) in his report has unveiled that due to some unavoidable circumstances visit could not be made therefore on the basis of earlier assessment, fees may kindly be fixed. On 5-6-2013 representative of this institution appeared for personal hearing and they acceded the proposal of Member ( Medical education). Earlier this Institute has been kept under group " Average", subject to next visit we after due consideration put this institute under group Average for revision of fees structure.
5. On 08-05-2013, 15-05-2013, 22-05-2013, 29-05-2013, 05-06-2013 and 13-06-2013 representatives on behalf of Institutions appeared for final hearing. During the course of hearing a number of institutions also proposed fees structure, in nutshell all institutions contended that they are required to incur heavy expenditure on payment of salary to faculty members and staff and due to rapid increase in prices of various materials they are also required sufficient amount to be utilized on other counts.
6. In Islamic Academy of Education vs. State of Karnataka<sup>1</sup>, Hon'ble the Apex Court in para 154 and para 198 has observed as below:

154. The fee structure, thus, in relation to each and every college must be determined separately keeping in view several factors, including facilities available, infrastructure made available, the age of the institution, investment made, future plan for expansion and betterment of the educational standard etc. The case of each institution in this behalf is required to be considered by an appropriate committee. For the said purpose, even the books of accounts maintained by the institution may have to be looked into. Whatever is determined by the Committee by way of fee structure having regard to relevant

factors, some of which are enumerated herein before, the management of the institution would not be entitled to charge anything more.

198. Thirdly, to ensure high standard of education and for that purpose to ensure admission to the most eligible candidates, requiring merit in a poor country like ours, the tuition and other fees should be within the reach of common people.

7. Following observations made by Hon'ble the Apex Court while rendering judgment in T.M.A. PAI FOUNDATION v. STATE OF KARNATAKA<sup>2</sup>, are also guiding factors for fixation of fee structure:

56. .... Different courses of study are usually taught by teachers who have to be recruited as per qualifications that may be prescribed. It is no secret that better working conditions will attract better teachers. More amenities will ensure that better students seek admission to that institution. One cannot lose sight of the fact that providing good amenities to the students in the form of competent teaching faculty and other infrastructure costs money.....

57. We, however, wish to emphasize one point, and that is that in as much as the occupation of education is, in a sense, regarded as charitable, the Government can provide regulations that will ensure excellence in education, while forbidding the charging of capitation fee and profiteering by the institution. Since the object of setting up an educational institution is by definition "charitable", it is clear that an educational institution cannot charge such a fee as is not required for the purpose of fulfilling that object. To put it differently, in the establishment of an educational institution, the object should not be to make profit, in as much as education is essentially charitable in nature. There can however be a reasonable revenue surplus, which may be generated by the educational institution for the purpose of development of education and expansion of the institution.

8. Section 9 of the Act prescribes factors required to be considered for fixation of fee and those factors are as below:
1. the location of the private unaided professional educational institution;
  2. the nature of the professional course;

3. the cost of land and building;
  4. the available infrastructure, teaching , non-teaching staff and equipments;
  5. the expenditure on administration and maintenance;
  6. a reasonable surplus required for growth and development of the professional institution;
  7. any other relevant factor.
9. Thus it is clear that for final fixation/revision of fee structure not only factors prescribed under Sec. 9 of the "Act" are required to be considered but also we are required to make effective the observations of Hon`ble the Apex Court.
10. During the course of hearing it has come to our notice that State Government while recommending the matter for commencing B.Ed course by private institute have in clear words put specific condition that it is for the institute to arrange from their own resources building , furniture, fund and other necessary requirements as per the norms of NCTE therefore these expenditure cannot be recovered from students in the shape of fees.
11. We are of the considered view that only reasonable recurring expenditure incurred by the institute should be borne by the student in the shape of fees. We are of the considered view that following are some of the prominent heads, against which reasonable expenditure incurred by the institutions should be borne by the student in the shape of fees. Member (Finance) taking into account the above heads has calculated expenditure per candidate per year.





12. So far as depreciations are concerned the same are allowed under certain laws for calculating actual income for considering those income under various provisions of those laws. To meet the requirements of syllabus and norms prescribed by NCTE/University, institutions are required to incur expenditure. Equipments, books, computer etc purchased by the institutions does not loses its utility, even computers are updated. There is a distinction in between educational institutions and individual. So far as fixation of fee is concerned depreciations allowed under various laws for computing income has no role to play even then we are of the considered view that for the sake of calculations if up to 10% of the reasonable actual expenditure, but not on estimated/ hypothecated expenditure, incurred by institutions are allowed towards depreciations that will meet the ends of justice.
13. Hon'ble the Apex Court in the matter of *PA Inamdar vs. State of Maharashtra (2005 AIR SCW 3923)* have held " Education , accepted as a useful activity, whether for charity or for profit, is an occupation. Nevertheless, it does not cease to be a service to the society. And even though an occupation, it cannot be equated to a trade or a business."
14. Interest on borrowed fund may play role in trade and business but cannot be considered in the field of "Education" for fixation of fees. Earlier the matter also came for consideration before Fees Committee Presided over by Hon'ble Justice Jha, and the said committee disallowed claim of interest observing that " In the criteria laid down in *Islamic Studies Centre Case judgment* interest on loan is not mentioned as a criterion . Even otherwise, it is felt that ordinarily the college should manage from its own resources and if loan at all becomes necessary burden of its interest should not be passed on to students as is done in trade, business, industry and the like by recovering the same from consumer as imparting education, as held by Hon'ble the Supreme Court is essentially charitable in nature. Interest on loan if allowed to be recovered from students as part of the fee paid by them can lead to serious abuse. Interest on loan therefore cannot be taken into consideration

for determining the fee structure.” Justice Jha Committee did not allow interest on loan in considering fee structure. AFRC fixed fee structure for various courses run by various institute, and while fixing the fee structure, if any of the institute has claimed interest on loan that has been disallowed by the AFRC, all those fee structure reached their finality and AFRC cannot discriminate institutes by allowing interest on loan a factor for fixation of fee to any one.

15. People of Chhattisgarh are not rich, earlier per capita income in Chhattisgarh in the year 2010-11 was around Rs. 41,167/- in the year 2011-12 it was around Rs. 46,573/- and it has been claimed that the same has been increased and now it is around Rs.52,689/-. This itself is sufficient to consider the plight of most of our pupils.
16. We have considered each and every institution separately for fixation of fees structure, considering the guidelines of Apex Court, contentions of institutions, material available and the factors as required under the Act. Information, institution wise is narrated as below.

It has come to our notice that some of the above institutions are multi-faculty institutions and it appears that instead of furnishing audit report for relevant course they have furnished complete audit report of their institutions therefore it was not possible to accurately calculate expenditure per student per year. Some of the institutions are running both B.Ed and M.Ed courses but they did not furnish audit report or information in Form B separately therefore Member ( Finance ) taking intake of both the courses has calculated expenditure per student per year. According to some of the Audit report expenditure per student has been found higher than the information furnished by the institutions in Form B , that itself shows that audit report does not relate only to B.Ed and M.Ed courses. In some of the matters it has been found that according to audit report the expenditure per student is less than the expenditure shown in Form B. In some of the matters it has been found that proposals given by the institute during the course of personal hearing is less than the expenditure calculated per student on audit report and Form B. Some of the Institutes did not file audit report. Information given in Form B are not actual figure but are only hypothetical figures. Some of the institutes without audit report have furnished a very high figure in Form-B and considering expenses of other alike institutions does not appear to be just reasonable and correct figures. Under these circumstances expenditure per intake student calculated by Member (Finance) are not acceptable as a material criteria/fact for fixation of fee, even otherwise fees is to be fixed considering a number of various factors as discussed above.

18. It is well known feature that for attracting good faculty, higher salary and better amenities are the basic elements these days, however so far as B.Ed course is

concerned it appears that there is no scarcity of faculties in the State that is why faculty members, despite our earlier recommendation, in number of institutions are paid poor salary and in general they are paid the scale of Rs. 8,000/- 275/- 13500/-. Excepting a few, most of the institutions are run by In-charge Principal and they are actually senior faculty member of that institution. For B.Ed Course for a basic unit of 100 students only one Principal and seven Lecturers are required and for M Ed for a basic unit of 25 students one professor/head, one Reader/Ass.Professor and three Lecturers/AP are required. B.Ed./M.Ed. course is of one year program. Although prices, not only of daily needs but also of other amenities have been increased beyond our expectation yet cost of faculty members of this discipline does not appear to be increased. For quality education various factors play their role, some of them are good faculty, better amenities, better infrastructure, educational atmosphere etc. It is not a secret that for becoming teacher now a days requirement of degree of B Ed is there and only to compete for the post of teachers a good number of candidates take admission in B.Ed course. Per capita income itself is suggestive of pocket capacity of such candidates. Therefore considering all factors as discussed above, contentions of institution, all facts and legal aspects as mentioned above, ground reality, various petty expenses which require to be incurred by institution and without ignoring the pocket capacity of students to pay the fee for quality professional education we are required to fix per year payable consolidated fee comprising tuition fee, other fees and growth and development charge (excluding charges for users facilities, prescribed fees payable to University and prescribed fees payable to Counseling Authority). For fair and transparent fixation of fee we are of the considered opinion that the fee should be fixed applying following methodology.

**Methodology applied for fixation of fees of KRUTI INSTITUTE OF TEACHER EDUCATION for B.Ed. Course FOR 2013-14, 2014-15 & 2015-2016:-**

Recently vide resolution dated 06-02-2013 AFRC after due consideration of all relevant factors for academic sessions 2012-13, 2013-14, & 2014-15 has announced fees structure for 29 institutions who started imparting B.Ed education from 2012-13 in Chhattisgarh, whereby fees for institutions falling in group Good has been fixed Rs. 29,000/- including incentive, Growth & Development Charges and all other misc. fees. To differentiate this institute with others except one factor and i.e. Commencement of course from 2013-14, there is nothing extraordinary, on

The fee calculated earlier under resolution dated 20-04-2011 for institute under group Good as above, in our most anxious and thoughtful consideration is an ideal, just and rational and therefore after due consideration of all facts, materials and contentions of the institute, we are pleased to accept the same, accordingly we announce the fee structure for this Institute as indicated below in the **Schedule-B** for the academic session 2010-11, 2011-12 and 2012-13. Institute is directed to refund if in any year they have collected fee in excess of the fee determined herein above to concerned students. If Institute has collected fee less than the fees fixed by AFRC as stated above, the fault lies with the institute therefore they cannot claim the difference amount from the students and Institute itself shall bear the same.

far as educational part is concerned fees for teaching, all the institutions deserves to be placed at par and are entitled for same fees but so far as development of aptitude is concerned it is the concerned institute which by providing educational atmosphere and other suitable facilities/ amenities gradually develop ability and smartness in students therefore they are entitled for reasonable incentive amount, so as to enable them to maintain the educational atmosphere and further to develop the same. Earlier after affording opportunities to institutions and after due consideration of all factors necessary for fixation of fee we have fixed fees including incentive, all misc. fee and growth and development charges vide resolution dated 20-4-2011 for academic sessions 2010-11, 2011-12, &2012-13 for B.Ed and for M.Ed course. Excepting a few ,rest of the institutions whose fees has earlier fixed as stated above are under consideration for revisions of their fees structure for another three years. we are of the considered view that basic fee for all institutions have been fixed vide resolution dated 20-4-2011 to be Rs.25,700/- per student per year for B.Ed course for academic sessions 2010-11, 2011-12 and 2012-13 holding the same to be an ideal, just and reasonable fee excluding incentive amount and the same has been reached to its finality therefore for revisions of this fees structure only question for determination is whether for another three years the same should be continue or should be increased and if increased to what extent.

It is not a secret that prices during last three years have reached to sky , in natural course institutions are morally bound to pay more to staff and also they are required to incur additional expenditure as a result of price hike. Taking into consideration all facts we are of the considered view that if 6% over and above the aforesaid amount is allowed that would meet the ends of justice, and on allowing so the amount comes to Rs.27,242/ (25,700/- +1542/-) rounded of Rs. 27,250/-.In our thoughtful consideration for institutions grouped under Very Good category an incentive of Rs. 2000/- for institutions grouped under Good category an incentive of Rs. 1500/- and for institutions grouped under category Average an incentive of Rs..1,000/- shall be just and proper.

So far as M.Ed course is concerned, although prices of goods are rapidly increasing and for providing better amenities to Faculty members and students, for better educational atmosphere, institute may require some additional expenditure. It has come to our notice that for M.Ed Course only those institutions are eligible who are

imparting B.Ed course even some of the institution running M.Ed. course are multi faculty institutions and for M.Ed. Course except opening higher course of lower discipline nothing special appears which may require substantial increase of fees on the other hand we feel that earlier we have already allowed fees for M.Ed. course on higher side which is basic Rs.45,000/- common for all institutes for academic session 2010-11, 2011-12, and 2012-13, the same reached to its finality and if the same basic fees of Rs 45,000/- is increased by 3% which comes to Rs. 1350/- and accordingly total comes to Rs.46350/- that will to be an ideal, just and reasonable fee excluding incentive amount and growth and development charges.. In our thoughtful consideration for institutions grouped under Very Good category an incentive of Rs. 2000/- for institutions grouped under Good category an incentive of Rs. 1500/- and for institutions grouped under category Average an incentive of Rs. 1,000/- shall be just and proper.

We expect with institutions who did not adhere to our earlier recommendation regarding paying respectable salary to faculty members shall respecting teacher education shall pay salary to them in accordance with law. We also expect with institutions who are not allowing CPF facility and Insurance scheme shall allow the same to eligible members

After due consideration earlier we allowed Rs.1,000/- towards Growth and development charges ,we did not find any material to alter the same therefore we allow the same for another three years.

We are allowing growth and development charges to each of the institutions and we have also allowed incentive to institutions as per assessment made by the committee therefore if for accredited courses for their validity period only a sum of Rs. 500/- per student per year in addition to above is allowed and that will be just and proper encouraging amount for those institutions and accordingly we allow .

19. After due consideration we fix Rs. 1500/- towards Caution Money (one time payable at the time of admission and refundable at the time of departure).
20. Growth and Development charges of Rs1,000/- included in total fees and surplus (if any) shall be utilized only towards Growth and Development of the B.Ed.or M.Ed Course as the case may be and would not be diverted or used for any other institution or work.
21. Charges for facilities like Mess, transport and hostel shall be optional and can be collected from users on no profit, no loss basis as per actual expenditure incurred in providing such facilities. Fees prescribed by the University payable by the student shall be collected from student and shall be remitted to the University as per their directions. Fees prescribed by the counseling authority payable by the candidate shall also be charged. Except above referred charges and fee, no other charges and fee are allowed to be charged for any other reason by the institute, and if charged or collected shall be presumed as charging capitation fee and shall be subjected to legal and penal action in accordance with law.
22. Refund of fees on cancellation of admissions:-

Following observations made by Hon'ble the Apex Court in TMA PAI FOUNDATION (Supra) is also a guiding factor for considering refund of Fees.

“Since the object of setting up an educational institution is by definition “Charitable”, it is clear that an educational institution cannot charge such a fee as is not required for the purpose of fulfilling that object. To put it differently, in the establishment of an educational institution, the object should not be to make profit, in as much as education is essentially charitable in nature.”

“The Act 2008” empowers the Admission and Fee Regulatory Committee, the work of supervision and guidance of admission process and for the fixation of fee to be charged from candidates seeking admissions in a

Private Professional Institution. The "Act" further empowers the Committee to enquire matters relating to collecting of capitation fee or fee in excess of fee determined or profiteering by an institution and to pass appropriate recommendations and declarations. From provisions as contained in the "Act" it is manifest that collecting of capitation fee or profiteering has been prohibited by the legislation.

In charity, there is no role of profit, loss, forfeiture, confiscation or penalty. The occupation of education is, in a sense regarded as charitable, as observed by Hon'ble the Apex court in TMA PAI (Supra) therefore so far as receipts from fees is concerned, cancellation of admissions or non-fulfillment of seats, have no bearing. There is no legislation empowering Private Professional Institutions to impose penalty or to forfeit any amount deposited by the student or to confiscate the advance fees or fees paid by the student. Fees fixed by the committee for a year means the fees has been fixed for twelve months. The fees as ascertained and fixed by the Committee has been fixed for students who are admitted and who pursue their studies further, and the fees is applicable only for that period for which a student continues his studies.


"Act" directs that the Committee shall ensure that the admission in an institute is done in a fair and transparent manner. The responsibility to enquire the complaints regarding collecting of capitation fee or profiteering has also been put on the shoulders of the committee.


As and when matter for refund of fees comes for consideration before any institute, the institute shall dispose of the same in accordance with law, legal pronouncements of Hon' HC and of Apex Court and observations contained herein.


As and when the question regarding refund of fees, collecting of capitation fee or profiteering comes for consideration before AFRC, the same may be disposed of by AFRC after due consideration of law applicable to the matter.

24. Fine/ penalty imposed by institutions :- Unless under any law power to impose fine or penalty has been authorised, institutions are not empowered to impose the same. University has already prescribed percentage of attendance for appearing in the examination, therefore if any student remains absent and does not fulfill the required attendance she/ he may be disqualified from appearing in the examination by the University therefore for absence neither fine nor penalty can be imposed by the institutions.
25. Collecting of capitation fee or fee in excess of fees fixed by the Committee or fees and charges not herein above mentioned or profiteering by any institution are prohibited therefore violation thereof shall be subject to legal action against the concerned institution.
26. **The consolidated fee fixed by the committee is the maximum fee chargeable by the institution. The institution if it thinks desirable or necessary would be at liberty to charge any lesser fee.**
27. Fees structure announced hereunder is applicable to Institutions subject to condition that they conduct courses under valid authorizations from concerned bodies/authorities.
28. Refund shall be made only through banking documents such as cheque, bank draft etc. Return of Caution Money shall be made only through Cheques or bank drafts.


